Affidavit for Arrest Warrant

The affiant, Investigator Donna Teague, being duly sworn and deposed, is a duly commissioned Colorado peace officer for the Boulder County District Attorney's Office, located in the County of Boulder, and the State of Colorado.

Around May 8, 2009, Deputy District Attorney Anne Pignatiello received information from attorney Harvey Steinberg. This information pertained to a client of Mr. Steinberg's, identified as Leonard Norman Cohen (09/21/34), who Mr. Steinberg represented in a civil protection order hearing in 2008 (08C776) at the Boulder County Court, Division 8. Mr. Cohen was seeking a protection order against his former business manager identified as **Kelley Ann Lynch (01/27/57), SSN: _____** Mr. Cohen was successfully awarded a permanent protection order against Ms. Lynch on September 2, 2008. Mr. Steinberg had gathered information that Ms. Lynch was violating the protection order by sending various email messages to Mr. Cohen's personal email address. Therefore, DDA Pignatiello requested that the affiant investigate a possible "Violation of Protection Order" pursuant to C.R.S. 18-6-803.5.

In reviewing the information provided by Mr. Steinberg's law office, I found that on Thursday, May 7, 2009, Ms. Lynch sent approximately five email messages addressed to Mr. Leonard Cohen's personal email address: [REDACTED]@aol.com.

1. 9:04 p.m. - Email consists of a human hand extending the middle finger. The subject is "With or Without YOU" and is from odzerchenma@gmail.com.
2. 9:12 p.m. - Email consists of the same human hand extending the middle finger. This too is from: odzerchenma@gmail.com.
3. 9:15 p.m. - Email consists of the same human hand extending the middle finger. It is from: odzerchenma@gmail.com.
4. 9:16 p.m. - Email is a picture of an unidentified Asian gentleman and is from: odzerchenma@gmail.com.
5. 9:18 p.m. - Email contains an unknown and unidentifiable picture. The subject of this email is titled "The Ruse". It is again from odzerchenma@gmail.com.

In order to confirm that Kelley Lynch owned the email account: odzerchenma@gmail.com, I completed a "Court Order for Production of Records". Once this order was reviewed and signed by Judge Noel Blum (Boulder County Court, Division 9), I sent it to Google Inc., on August 3, 2009 (through facsimile).

I received documentation on August 24, 2009, from Google, Inc., that the email account: odzerchenma@gmail.com did indeed belong to **Kelley Lynch (01/27/57)**, SSN:

In a CD that I received from Google, Inc., I discovered the following:

1. A six page, subscriber information list containing 34 different email addresses and accounts with Google's "Gmail". All of these addresses/accounts referenced to the name: Kelley Lynch. The very first address/account listed was to odzerchenma@gmail.com. According to the subscriber information, this account is currently disabled. This same email address/account was listed as a secondary email for the other 33 email addresses/accounts. (ATTACHED)
2. Ninety-four pages containing email messages sent from and received by the email address/account: odzerchenma@gmail.com. The emails sent to Mr. Cohen, listed above, were among the many email messages on this CD. (NOT ATTACHED)

I also was able to confirm that this email address/account belonged to Kelley Ann Lynch (01/27/57), SSN: _____ by reviewing some of the other email addresses/accounts.

- kelleyannlynch@gmail.com
- rayandrutgersmother@gmail.com (Ms. Lynch has two sons: John Rutger Penick and Ray Lindsey).
- kelleylynchandphilspector@gmail.com (Ms. Lynch had been caught up in the drama of the California homicide jury trial involving Phil Spector).
- Once again, these email addresses/accounts used odzerchenma@gmail.com as a secondary email address/account.

Furthermore, within the notebook of information from Mr. Steinberg's office, there were additional email messages that identified odzerchenma@gmail.com as Kelley Lynch. One such email was from "Craig's List" and consisted of Ms. Lynch posting an advertisement on "Craig's List" seeking employment in the Boulder area. This was at 5:36 p.m. on May 9, 2009 (MDT). She signed the advertisement with:

"Kelley Ann Lynch
odzerchenma@gmailcom"

This advertisement also included a resume' that detailed employment history that matches the employment history of "Kelley Ann Lynch", former manager to Leonard Cohen, and who is listed in the permanent civil protection order for 08C776.


As a result of this investigation, the affiant feels that there is sufficient probable cause to believe that **Kelley Ann Lynch (01/27/57; SSN: _____)** did commit "Violation of

Protection Order” as defined by C.R.S. 18-6-803.5. The affiant therefore requests that an arrest warrant be issued for **Kelley Ann Lynch (01/27/57), SSN:**


According to her California driver’s license (suspended/revoked) and her criminal histories (CA: 27764609) (CO: 2174479) (FBI: 169861PC8), Kelley Ann Lynch is described as a white female, 5’6”, 120 lbs., with blonde hair and blue eyes. Her social security number (SSN) is :


In California, she was arrested for local ordinance violations on September 29, 2006 and Disorderly Conduct on December 23, 2006.

In Colorado, she was arrested for “Obstructing Police” and “Trespassing” on January 8, 2008. On May 14, 2008, she was again arrested for “Obstructing Police”. On August 5, 2008, she was arrested for two outstanding warrants for failing to appear at court on the arrests from January 2008.
